The Australian Centre for Intellectual Property in Agriculture (ACIPA) in conjunction with Horticulture Australia Limited (HAL) is holding two free workshops on intellectual property and commercialisation for researchers, growers, industry associations and others involved in primary industries.

Workshop 1 – Intellectual Property Overview (9.45am – 12.30pm)

Workshop 1 will cover recent developments in intellectual property, particularly in the area of plant breeder's rights which are having more and more impact on the horticulture industry. New varieties are now commonly protected by plant breeder's rights, with growers having to pay tree and/or end point royalties to breeders. Trade marks, copyright and patents are also being used to protect new innovations in primary industries. Topics will include:

- Overview of Intellectual Property: patents, plant breeder's rights, trade marks, copyright and confidential information/trade secrets.
- Plant Breeder's Rights: scope, criteria, exemptions, enforcement, what does it mean for breeders and employers?
- Contracts and Intellectual Property: terms and conditions of use, closed loop, end point royalties and material transfer agreements.

Workshop 2 - Commercialisation and Adoption for researchers (1.15pm-4.00pm)

Workshop 2 is designed to help researchers and others involved in research management and investment, manage their intellectual property to maximise commercial outcomes. Topics will include:

- What is commercialisation of intellectual property (IP)?
- How to identify IP?
- Who owns the IP?
- To protect or not to protect?
- · Managing IP for maximum benefit.
- What does/should investors (eg R&D Corporations, CRCs, companies) expect in project applications?
